This bridal agreement is between Suziana Johnson hereafter referred to as "Suziana Johnson or makeup artist", and the "Client".

#### Fees:

Client agrees to pay Suziana Johnson a non-refundable retainer fee at the time of booking to secure the appointment (date and time). This deposit goes toward your service. The remaining balance is due at the start of the service. The Client shall pay a travel fee for all on-site services.

### **Late Arrivals:**

Any Client that is more than 15 minutes late arriving to a session will pay a \$20 late fee. This may also result in a reduction in the length of session and/or cancellation of appointment.

## Rescheduling/ Canceling:

Suziana Johnson reserves the right to reschedule or cancel due to illness, weather, equipment malfunction, or other circumstances beyond her control.

#### **Your Session:**

Please review images of my work to ensure that my style of artistry in beauty reflects you. When booking with me, you are giving me full reign over the appointed session. If you are opposed to any of this, my style of makeup artistry may not be a good fit for you. Better to discuss the look prior booking with me then after the session, as there are no refunds.

#### Transaction fee:

There will be a 4% transaction fee added to all payments made through debit or credit card.

# Clients Usage:

The Client shall only use digital images for personal use, in accordance with the permissions within this agreement. The Client may share images through various social networks such as Facebook, Instagram, Twitter,

Pinterest, Blogs etc. Client must give Suziana Johnson credit for all images shared via social networks.

## **Copyright, Reproductions & Penalty:**

All photographic materials taken by Suziana Johnson including but not limited to unedited RAW files/videoes and edited JPGs, shall be the exclusive property of Suziana Johnson. Suziana Johnson shall own the copyright in all images created and shall have the exclusive right to make reproductions for, including but not limited to, marketing materials, ads, portfolio entries, sample products, editorial submissions and use, or for display within or on the makeup artist website, studio, etc. It is understood that any duplication or alteration of original images is strictly prohibited without the written permission of the makeup artist.

#### **Failure to Perform:**

If the makeup artist is unable to perform this agreement due to illness, emergency, fire, casualty, strike, act of God or causes beyond the control of the Photographer, the makeup artist and Client shall make every attempt to reschedule the session. Further, lability shall be limited to the deposit amount.

# **Liability:**

Makeup artist is not responsible for any injuries inflicted upon any participating parties. Client(s) will be responsible for their children and for themselves and release makeup artist from any claims against their person or their business. The Client(s) will waive, disclaim and release Suziana Johnson and its respective owners, members, employees, agents, volunteers and representatives from any and all actions, claims or demands that they may have now or in the future, whether known or unknown, against the makeup artist Parties, including without limitation those related to injury to or death of persons, or damage, loss or destruction of property arising out of or in connection with the Session or any products related thereto.

If any equipment used by Suziana during the course of the services is damaged, destroyed or stolen by the client, the client's guests, affiliates, friends, family members or any other person who the clients brings with them to their session, the client shall reimburse AP for 100% of the costs to

fix the damage or 100% of the replacement cost of the equipment at the discretion of Suziana Johnson.

### Indemnification:

The client hereby agrees to indemnify and hold harmless the makeup artist Parties from all liabilities, losses, claims, costs (including attorney's fees and court costs), damages or expenses of whatever nature that may result from injury to or death of persons, or damage, loss or destruction of property arising out of or in connection with the Session or any products related thereto.

# **Refund Policy:**

The Client(s) hereby agrees that he/she fully understands that there are no refunds or exchanges.

### **Bride:**

Suziana Johnson and The Client has agreed to a look prior to the wedding ceremony for herself and/or bridal party. Members of the bridal party must have one unison look with. Please discuss with the makeup artist the best look to compliment you and your bridal party prior. All bridal party members must be present for their individual appointments. Members of the bridal party has no creative control outside of what was finalized with The Client the day of the ceremony. Suziana Johnson will follow strict request which is contracted and in e-mails. Client please discuss this with your bridal party prior.
